**DEPARTMENT RULES**

1. General rules and regulations and health requirements listed on the Iowa State Fair website and in the FFA section apply in this department, with special emphasis on the following sections: Member Eligibility, Supervision and Lodging, Good Conduct Policy, Medication and Drug Testing and Showing and Fitting Ethics.
2. **Nominations must be submitted online on or before February 1 (Performance Beef) or May 15 (Breeding Beef and Cow-Calf).** Nomination fee for Performance Beef is \$4 per head. No fee is required to nominate Breeding Beef or Cow-Calf.
3. **Entries must be submitted online on or before July 1.** Entry fee is \$25 per head/pair. Animals not entered will not be permitted to show.
4. **All Commercial Heifers, Crossbred, Grade and Registered Cows and Registered Bulls and Heifers must be tattooed on or before May 15. Animals with fresh tattoos will not be permitted to show. Tattoos must be legible and can be read without question. Calfhood vaccination tattoos are not acceptable for I.D. Animals may have ear tags but they are not required.**
5. Common bedding will be used in the barns for all beef cattle. The stalls will be bedded by the Iowa State Fair Maintenance staff. No alternative bedding will be allowed on the grounds. Exhibitors will be allowed to purchase additional bedding to freshen stalls, but there will be a standard depth maintained.
6. Animals exhibited in this division must be housed Wednesday, August 8 - Thursday, August 9 in stalls designated by the FFA Beef Supervisors or forfeit all premiums earned. Beef entries from a school will be assigned adjacent stalls. **No FFA Beef at the Iowa State Fair will be permitted to be displayed or fit for show in breed association exhibits, Open Class, 4-H or other stalls for any reason before release time on August 9 or premium money will be withheld.**
7. Exhibitors must attend the exhibitor meeting at 7:30 p.m. on Tuesday, August 7 in the Cattle Barn Media Center.
8. All cattle must be in their stalls from 8:00 a.m. to 6:00 p.m., each day of exhibition.
9. Exhibitors must keep the space in the rear of their stalls clear and clean; all litter must be thrown where indicated by the supervisors of the department. Exhibitors are requested to cooperate in the use of blocking chutes, using the minimum number of chutes per school and placing in an area designated by the cattle supervisors. Exhibitors are not to purchase extra stalls for blocking chutes. **Each FFA Chapter will be limited to one set of stall dividers.** Failure to cooperate will result in withdrawal of premium money from beef classes. **No tack may be placed in the barn prior to 8:00 a.m. on Tuesday, August 7. Tack space is on a first come first serve basis. The use of butt fans is prohibited in all barns (see General Livestock Rules). Limit of one fan per animal on halter side.**
10. Any artificial means of removing or remedying physical defects of conformation in animals exhibited will be considered as fraud and deception. **No unnatural means of providing an animal feed, water or other fluid (i.e. stomach pump, drench gun, IV) will be allowed.** All animals giving evidence of such treatment will be barred from exhibition at the Iowa State Fair.
11. **Painting, dyeing and use of color agents on beef animals is not condoned by Iowa State Fair Officials. Beef projects which show evidence of this will not be permitted into the show ring. If a color or coloring agent rubs off an animal rubbed with either a towel or hand, that animal will be disqualified. Exhibitors can use colored grooming aids on hooves only. Animals subject to toweling.**
12. No artificial aides such as tail head or tail fins will be permitted.
13. After a class has been placed in the show ring, officials reserve the right to re-inspect animals for color or sharp practices. If such is found, the animal will be barred from further championship competition and forfeit all premium money.
14. **Each FFA member shall take responsibility for caring for and grooming his/her own animal(s). If assistance is needed it should be intended to help the FFA member learn new skills. FFA members can be assisted by an immediate family member, fellow active Iowa FFA member and/or chapter advisor in fitting and grooming their cattle. No other assistants will be permitted. Anyone found in violation of this rule will be disqualified.**
15. Only the exhibitor and one helper will be allowed into the holding area once the cattle are checked in for the show.
16. All beef animals must be on a halter at all times. Absolutely no loose beef animals will be allowed.
17. A purple, blue, red or white ribbon will be awarded to each entry. Placing ribbons will also be provided to the top ten places in each class. Rosettes will be awarded to the Champion and Reserve Champion in each division. **Only purple and blue ribbon winners can be named Champion of a show/division/class.**

**BREEDING BEEF  
SPECIAL RULES**

1. Breeding beef exhibitors must follow FFA Beef Department rules listed above.
2. **Nominations must be submitted online on or before May 15.** A maximum of 20 heifers and bulls may be nominated. Classes will be determined at the Fair during check in.
3. All FFA Breeding Heifers and Bulls must be owned by the nomination due date and ownership maintained through the date of exhibition at the Iowa State Fair by the exhibitor, or in a partnership, school cooperative or a corporation.

4. **Entries must be submitted online on or before July 1.** Entry fee is \$25 per head. Each exhibitor may enter a maximum of eight heifers and bulls in the Breeding Beef show.
5. Registration, transfer papers and ear tattoos will be checked; and Commercial Heifers will be weighed after Performance check in on Wednesday, August 8. Papers will be checked in the morning.
6. In each registered beef class, heifers and bulls will enter the show ring in order by birth date.
7. Registered heifers born from January 1, 2017 through December 31, 2017 and from September 1, 2016 through December 31, 2016 may be exhibited. FFA registered heifers will be divided into classes as determined by the Beef Committee. There are no classes for registered heifers born after December 31, 2017. There are to be no more than 12 heifers in a class.
8. Commercial heifers born from January 1, 2017 through December 31, 2017 may be exhibited. Commercial Heifers will be divided into classes according to weight instead of age. The supervisor reserves the right to determine classes.
9. Registered bulls born January 1, 2017 through December 31, 2017 may be exhibited. There are no bull classes for commercial animals.
10. **A breed must have at least four head to have a breed show under the divisions of heifer, cow/calf and bulls.** A breed may have a separate sub-class under its class if it has four or more entries. Otherwise, they will be combined and show in the All Other Breeds (AOB) class.
11. Heifers and bulls will be judged on the basis of breeding condition, breed characteristics, quality and conformation. Probable usefulness as a breeding animal will be stressed. The breed association's determination of what is classified as purebred or registered in that breed will be accepted.
12. Premiums in each Beef Heifer and Bull Class (not including Champions) will be pro-rated with a maximum of \$112 per class based on the following approximate monetary amounts: 20, 15, 10, 9, 8, 8, 7, 6, 6, 6, with all other entries receiving \$5. In the event a class does not have its full quota, premium money will be paid as follows: Example - eight in a class, the premiums paid will be: \$22, 17, 11, 10, 9, 9, 7, 6.
13. **PRODUCE of DAM** - Heifers and bulls must be the produce of a dam presently or formerly enrolled by the member as a FFA project. Heifers entered as such must be shown in their respective breed class. For those heifers and bulls the judge declares to be worthy of recognition at the time of placing the class and that were entered as Produce, \$5 will be added to the premium awarded in the class. To be eligible for this incentive premium, "Produce" must be indicated on the entry form.

**COW-CALF  
SPECIAL RULES**

1. Cow-Calf exhibitors must follow FFA Beef Department rules listed on previous pages.
2. **Nominations must be submitted online on or before May 15.** A maximum of five cow-calf units may be nominated.
3. The cow which gave birth to the calf must have been owned by the FFA exhibitor at least 60 days before calving. Ownership must be maintained through the date of exhibition at the Iowa State Fair by the exhibitor, or in a partnership, school cooperative or a corporation.
4. **Cows must be tattooed; ear tags are fine but will not be required. Each calf must be ear tagged or tattooed. Cows with fresh tattoos will not be permitted to show.**
5. Calves must have been born January 1 through June 30, 2018 and may be either female or male. Calf must be the cow's most recent natural calf.
6. **Entries must be submitted online on or before July 1.** Entry fee is \$25 per cow-calf unit. Each exhibitor may enter a maximum of two cow-calf pairs.
7. **Classes will be based upon breed of the cow.** The breed must be designated on the nomination form and registration papers must be presented at the Fair to exhibit in those listed breed classes.
8. Exhibitors must provide registration papers on all registered cows.
9. The cow and calf must both be broke to lead and will both be tied at the Fair.
10. Each class must have at least four entries or classes will be combined. A breed may have a separate sub-class under its class if it has four or more entries.
11. Classes will be judged on breeding quality of the dam and productivity efficiency of the dam (50%). The quality and growth of the calf will also be evaluated (50%). Cow/calf classes will be split by the age of the cow.
12. All premium money will be pro-rated based on \$112 per class based on the following approximate monetary amounts: 20, 15, 10, 9, 8, 8, 7, 6, 6, 6 with all other entries receiving \$5. No cow-calf units will receive produce-of-dam premium money.

**CHAPTER AWARD**

THE SUPREME BREEDING BEEF EXHIBITOR'S AWARD recognizes the cooperative efforts of a chapter. The premiums are awarded to the chapters with outstanding over-all exhibits of registered beef, commercial heifers and cow-calf units. No entry form or entry fee will be required. The premiums are based on a point system. A committee will tabulate the results during the progress of the show.

Chapter Award - \$15 and Banner, \$10, 8, 6, 5, 4, 3, 2 to the top eight chapters; Ribbons, 2<sup>nd</sup> through 10<sup>th</sup> place.

**PERFORMANCE BEEF - DIVISION 4**

**SPECIAL RULES**

1. Performance beef exhibitors must follow FFA Beef Department rules listed on previous pages.
2. **Nominations must be submitted online on or before February 1.** Nomination fee is \$4 per steer. A maximum of six steers may be nominated.
3. Entries are open to market steers - purebred, grade or crossbred. Animals must have been weighed between November 1, 2017 and January 15, 2018 inclusive. Notification will be sent to the exhibitor and FFA advisor when the Performance Beef Committee has ruled a nomination is disqualified.
4. All FFA performance steers must have been weighed and identified at an approved county weigh-in site. Steers must have been identified by all of the following methods:
  - a. An FFA issued ear tag
  - b. A tattoo in at least one ear
  - c. Nose print taken at county weigh-in site
  - d. Hair sample taken at county weigh-in site
5. **All Performance Beef steers must be tattooed. All steers from the same FFA member and/or FFA family must have different tattoos. Steers with fresh tattoos or no tattoos will not be permitted to show. The steer may load to truck and the member will receive carcass data. Tattoos must be legible and can be read without question. Calfhood vaccination tattoos are not acceptable for identification.**
6. **Entries must be submitted online on or before July 1.** Entry fee is \$25 per head. Each exhibitor may enter a maximum of three performance beef steers with no more than two entries shown in one specific window. The third must be entered and shown in a different window. An exhibitor may enter and show each steer in a different window.
7. If an exhibitor enters more than three performance beef animals on the entry form, he/she will have five days upon notification to correct entry form or all performance beef animals entered by this exhibitor will be disqualified from the FFA Performance Beef Show.
8. All animals must be halter broken and manageable by the exhibitor. They will be clean, but no credit will be given for grooming except for showing awards competition. No glitter.
9. Exhibitors must attend the exhibitor meeting and educational presentation at 7:30 p.m. on Tuesday, August 7 in the Cattle Barn Media Center.
10. All exhibitors must turn in a signed affidavit for COOL and medication given to their animals. These will be kept on file for the packer. All animals will be drug tested by the packer.
11. The number of beef in each live class will be determined by the number shown and will be divided by nomination weigh-in weight in each specification

window - A, B and C.

12. All FFA performance beef at the Iowa State Fair will be subject to urine, blood and tissue analysis for diuretics and anabolic compounds and feed additive or drug residues at the discretion of show management or federal inspector. Positive tests will result in forfeiture of premiums and sale price.
  13. Each animal must compete in the live show to qualify for a performance placing. If an animal gets loose from the exhibitor three times during the show, it will be disqualified from the live and performance shows. The animal can be sent to the packing plant, but will not be included in show results.
  14. All FFA performance beef animals will be picked up immediately after showing for delivery to a designated packing company.
  15. No animals in this division may be held for Open Classes.
  16. Results will be tabulated after receiving the final carcass sheet.
  17. A purple, blue, red or white ribbon will be presented to each entry in both live and performance classes. Placing ribbons will be given to the top ten places in both live and performance class windows.
  18. A special produce class for animals raised by the exhibitor from a cow owned by the exhibitor and enrolled in the exhibitors SAE program will be available. **Eligible animals should be entered by placing a check mark in the box on the nomination form designated for produce. Produce animals will be given special recognition as they are exhibited by designation on the exhibitor number (catalog number). They will show with each class. The overall placing will determine the produce live placing.** No additional entry fee will be charged for the Produce class. Special banners and ribbons will be given for both live and performance placings.
  19. The price received by each exhibitor will be the current carcass price for the day of processing. All standard industry discounts for grade, weight, bullocks, dark cutters, trim, etc. will be applied by the packer.
  20. **Exhibitors are reminded that there may be substantial price cuts on heavy carcasses; the packer will determine these cuts.**
  21. Checks for the animals will be sent by the Iowa State Fair using figures supplied by the packing plant. Trucking, packer fees and other related expenses will be deducted from exhibitor checks.
  22. Entries with hot dressed beef weight of less than 600 pounds will not be considered for Performance Beef premiums. Performance placing will be based on value of saleable meat per day on test. **Premiums will be paid on performance placings.**
  23. The following formula is to be used -  
**Calculate % Retail Product:**  

$$[65.69 - (9.931 \times \text{Fat Thickness}) + (1.2259 \times \text{Rib Eye Area}) - (.013166 \times \text{Carcass Weight}) - (1.29 \times \% \text{Kidney, Pelvic and Heart Fat})]$$
**Calculate Carcass Value Added Per Day on Feed: CV/DOF=**  

$$\frac{[\text{Hot Carcass Wt.} - (.55 \times \text{Starting Wt.})] \times \% \text{Retail Product} \times \text{Carcass Price, } \$/\text{lb.} / (.70)}{\text{Days on Feed}}$$
- The Hotel-Restaurant Window (C) will have premiums added for High Choice, and Low Prime and above of \$2.50 and up to \$5.00 per cwt. above the choice base bid respectively. For Lean-Lite Beef (B), the price bid for Choice cattle will be used in the formula for Select and Choice quality grades. Prices received for the cattle will be those as bid by the packer the day of processing. Generally prices received are bids based on 600 to 1050 pound carcasses with discounts applied for Select, Standard and Bullock grading carcasses. Other discounts that can apply are for over 1050 pound carcasses, under 600 pound carcasses, and Yield Grade 4 and 5 carcasses. Cattle payments reflect subtractions for trucking, inspection, yardage, beef checkoff, data collection and dark cutter assessment.
24. At entry time, each exhibitor will choose one of the following three specification windows to exhibit each of his/her animals live and in the performance competition. An animal shall be exhibited in only one of the specification windows.

Each animal not meeting the minimum specifications within a specified window will not qualify for a purple or blue award; animals not meeting the window specifications of their class will receive a red or white ribbon.

Any animal placing 1<sup>st</sup> through 5<sup>th</sup> which does not meet all specifications within a specified window will not receive prize money.

25. Prize money will be 125, 100, 75, 50, 25, paid to each of the three specification windows, for animals meeting window specifications, for the 1<sup>st</sup> through the 5<sup>th</sup> place with the balance prorated as premiums from first to last according to carcass value per day on feed and ribbon placings, according to money available. Premiums are paid on carcass placings only. Red and white ribbon animals (those not meeting specification window values) will

be paid a premium rate to be determined by a percent value of the carcass value per day on feed. Determination will be made by dividing the last place value in the blue ribbon group by the value of the highest place animal of the three windows combined. Each value per day on feed not meeting window specifications (or in the red ribbon groups) will be multiplied by this percent figure to find a value per day on feed figure that will then be used to figure the premium for that animal that will be paid. Those entered and shown in the Produce Class will be paid an additional \$5 in addition to Produce ribbons. The Champion Produce Performance Beef entry will receive \$25 premium.

The **Iowa Angus Breeders Association** offers trophies for the Champion and Reserve Champion heifer; Champion and Reserve Champion bull; and Champion and Reserve Champion cow/calf.

The **Iowa Beef Breeds Council** will award \$500 to the junior exhibitor of the highest ranking heifer purchased from each breed sale at the 2018 Iowa Beef Expo and exhibited at the 2018 Iowa State Fair. Heifers will be ranked at the discretion of each breed association under the following conditions:

1. The heifer must have been purchased in an Iowa Beef Expo sanctioned sale and exhibited by a junior at the 2018 Iowa State Fair.
2. Only one heifer per breed sale (13 total) will be awarded. Therefore, high and low percentage will be considered for one award. Furthermore, cattle with multiple registrations may only be awarded by the breed association which sold those cattle at the 2018 Iowa Beef Expo.

The **Iowa Hereford Breeders Association** will give awards for the Champion and Reserve Champion Hereford (combined horned/polled) heifers.

The **Iowa Simmental Association** offers a total of \$300 to the FFA Performance Beef winners. \$100 will be awarded to the winner in each of the three windows providing the winner has a 50% or more Simmental registration paper issued by the American Simmental Association.
